BOARD OF TRUSTEES

Two laypersons to be elected to a three-year term ending in 2027



Name: Nicholas Byrd Church: Calvary, East Liberty

Occupation: Software Engineering Manager

My name is Nicholas (Nic) Byrd. I am a lay member of Calvary in Pittsburgh, where I have been attending services for the past 9 years. Prior to that, I was a member of St. Paul's Episcopal Church in Salem, Virginia, where I was the youth representative to the vestry from 2003-2004. Professionally, I am a software engineering manager at Google where I set technical direction for engineers working on Shopping-related searches.

Previously, I developed backend services at Amazon and led the development of a county tax collection and disbursement product at Tyler Technologies. I have an undergraduate degree in Computer Science from Princeton University.

St. Paul's in Salem is a small parish, and like many parishes, it struggles with finances, leadership, and membership. My two children were baptized there four years apart and have consecutive annotations in the church's baptism registry. Unfortunately, its struggle for survival is not atypical, and many parishes now face financial desperation and declining membership. These factors confound and can lead to short-term decision making, infighting, and more rapid decline. My interest in the Board of Trustees is to contribute to the continued sustenance, maintenance, and growth of the Episcopal Church in the Pittsburgh region.

I was born and raised in Lancaster County. I graduated from the University of Delaware in 1981 with degrees in Political Science and Economics. In 1984 I earned my law degree from the University of Virginia, at which I was recruited by Eckert, Seamans to come to Pittsburgh as an associate attorney in 1984. Over the next 26 years I practiced law at two more private law firms and the corporate law departments of 4 Pittsburgh

companies. For the past 15 years I have been a senior associate counsel at UPMC, and since 2016 also a Vice President, focusing on physician employment contracting.
